1.0 Scope

1.1 Document

This document is to specify the product requirements for **802.11g USB module**. This USB module is based on Conexant chipset that complied with IEEE 802.11b and 802.11g standards from 2.4~2.5GHz, and it can be used to provide up to 11Mbps for IEEE 802.11b and 54Mbps to connect your wireless LAN.

With seamless roaming, fully interoperability and advanced security with WEP standard, **802.11g USB module** offers absolute interoperability with different vendors' 802.11b/g Access Points through the wireless LAN.



As long as 3 conditions above are met, further transmitter test will not be required. However, the OEM integrator is still responsible for testing their end-product for any additional compliance requirements required with this module installed (for example, digital device emissions, PC peripheral requirements, etc.).

IMPORTANT NOTE: In the event that these conditions can not be met (for example certain laptop configurations or co-location with another transmitter), then the FCC authorization is no longer considered valid and the FCC ID can not be used on the final product. In these circumstances, the OEM integrator will be responsible for re-evaluating the end product (including the transmitter) and obtaining a separate FCC authorization.

End Product Labeling

This transmitter module is authorized only for use in device where the antenna may be installed such that 20 cm may be maintained between the antenna and users. The final end product must be labeled in a visible area with the following: "Contains FCC ID: RRK2005070154-1".
