USB Drag & Drop

You can transfer your pictures, videos, music, story books from your computer to your Cruz[™] Reader's memory card or internal storage.

• With a memory card inserted, connect a mini USB data cable from your Cruz[™] Reader's mini USB port to a USB port on your computer.

• On your computer, located and click on the "Removable Disk" icon to access the tablet's memory card or internal storage.

• Drag & drop your pictures, music, videos, story books to either the Cruz[™] Reader's internal storage or memory card. Note: You can store the files either in the root directory or create appropriately named folders for categorization.

•When you're done, select the "Safely Remove Hardware" feature on your computer.

Battery Use & Safety

Important: Handle and store batteries properly to avoid injury or damage.

DON'Ts
