





Go to **Start** > **Run** > type **cmd**. A window similar to this one will appear. Type **ping xxx.xxx.xxx**, where **xxx** is the **IP address** of the wireless router or access point. A good wireless connection will show four replies from the wireless router or access point, as shown.

Troubleshooting

This chapter provides solutions to problems that can occur during the installation and operation of the DWL-AG132. Read the following descriptions if you are having problems. (The examples below are illustrated in Windows XP. If you have another operating system, these solutions will still apply although the appearance on your computer screen may differ.)

1. How do I check to see that the drivers for the DWL-AG132 are installed properly?



2. What variables may cause my wireless products to lose reception?

D-Link products let you access your network from virtually anywhere you want. However, the positioning of the products within your environment will affect the wireless range. Please refer to **Installation Considerations** in the **Wireless Basics** section of this manual for further information about the most advantageous placement of your D-Link wireless products.

3. Why does my wireless connection keep dropping?

If you are using 2.4GHz cordless phones, X-10 equipment or other home security systems, ceiling fans, and lights, your wireless connection will degrade dramatically or drop altogether. Try changing the channel on your router, access point and wireless adapter to a different channel to avoid interference.

Keep your product away (at least 3-6 feet) from electrical devices that generate RF noise, like microwaves, monitors, electric motors, etc.

4. Why can't I get a wireless connection?

If you have enabled encryption on the DWL-AG132, you must also enable encryption on all wireless devices in the network in order to establish a wireless connection.

The encryption settings are: 64-,128- and 152-bit. Make sure that the encryption bit level is the same on the router and the DWL-AG132.

Make sure that the SSID on the wireless router (if you have one in your network) and the DWL-AG132 are exactly the same. If they are not, wireless connection will not be established. The default SSID is **default**.

• Products purchased and delivered within the fifty states of the United States, the District of Columbia, U.S. Possessions or Protectorates, U.S. Military Installations, addresses with an APO or FPO.

Limited Warranty: D-Link warrants that the hardware portion of the D-Link products described below will be free from material defects in workmanship and materials from the date of original retail purchase of the product, for the period set forth below applicable to the product type ("Warranty Period"), except as otherwise stated herein.

1-Year Limited Warranty for the Product(s) is defined as follows:

- Hardware (excluding power supplies and fans) One (1) Year
- Power Supplies and Fans One (1) Year
- Spare parts and spare kits Ninety (90) days

D-Link's sole obligation shall be to repair or replace the defective Hardware during the Warranty Period at no charge to the original owner or to refund at D-Link's sole discretion.
