# REGULATORY STATEMENTS

#### FCC Certification

This card also allows you to take full advantage of your computer's mobility with




# **Wireless Network Options**

This network installation lets you set a small wireless workgroup easily and quickly. Equipped with USB port, you can share files and printers between each PC and laptop.




You can also use one computer as an Internet Server to connect to a wired global network and share files and information with other computers via a wireless LAN.

# **SOFTWARE INSTALLATION**

### Install the device

- 1. Make sure the computer is turned off. Remove the expansion slot cover from the computer.
- 2. Carefully slide the **802.11b/g/n 2T2R WLAN** into the USB slot. Push evenly and slowly and ensure it is properly seated.
- 3. After the device has been connected to your computer, turn on your computer. Windows will detect the new hardware and then automatically copy all of the files needed for networking.



# **Install the Driver & Utility**

- 1. Exit all Windows programs. Insert the included CD-ROM into your computer. The CD-ROM will run automatically.
- 2. Manually install driver from Device Manager

# Verification

To verify if the device exists in your computer and is enabled, go to **Start** >
