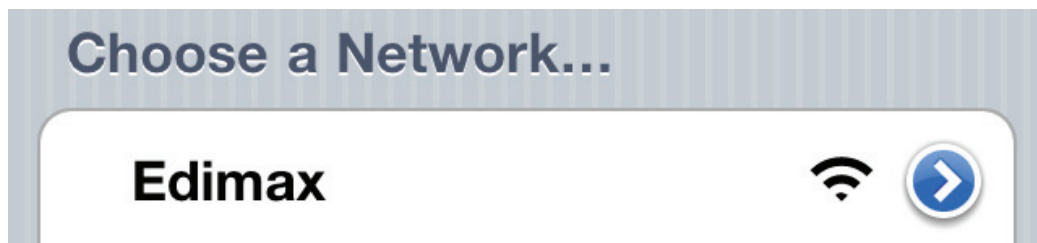
Next, click “Perform iQ Setup” to establish a connection automatically. iQ Setup will start detecting your Internet service type.



Note: You can click “Connect to the Internet manually” to log in the user interface. Input “admin” in the “Username” field and “1234” in the “Password” field when prompted.

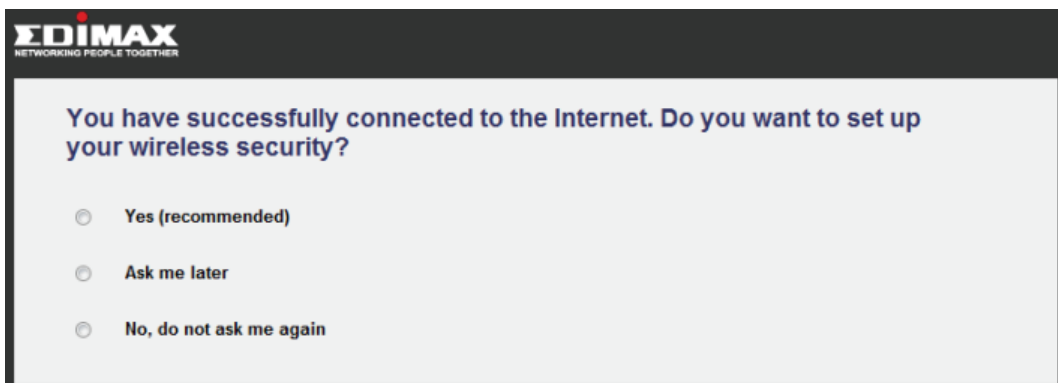






