1.1 LED Descriptions

- When modem is establishing the connection, the LED will be blinking.
- When modem is connected, the LED will be on steadily.

1.2 Front Panel

Connect this connector with Type-B end of USB cable.



1.3 Rear Panel

Connect this connector with RJ-11 cable.

3. Hardware Installation

- 1) Connect the provided RJ-11 cable into **LINE** port on the rear panel of the modem and insert the other end to splitter or wall phone jack.
- 2) Connect the provided USB cable into **USB** port on the front panel of the modem and insert the other end to PC or Notebook.

4. Driver Installation

4.1 Before You Start

4.2 Installing USB ADSL Modem

Step 1: When system detect new hardware, the Microsoft Windows "Found New Hardware Wizard" will be displayed, click "Cancel".

[For Windows XP, 2000, and ME]

In **Windows XP**, **2000**, and **ME** Operating System, the Easy Setup program will automatically reboot your computer. Once the PC has rebooted, Installation of the USB Modem is completed. The **Finished** window will be displayed indicating the installation has been completed. Click "**Finish**".



[For Windows 98SE]

For **Widows 98SE**, during the installation process, the system will ask you to insert Windows 98SE installation CD, please insert the CD and click "**OK**".
